		<p>Newspapers and on Commission's Website, candidates are inter-alia required to upload documents in support of educational qualifications and experience claimed by them in their online applications along with the application itself and in their absence, the applications are to be treated as 'incomplete'. However, in this recruitment case, candidates who have not submitted their degree /provisional degree/ marksheet in support of their educational qualifications along-with their ORA have been considered for short-listing subject to their submitting those documents later in support of their claim. But, candidate who have not submitted their experience certificate for the entire duration claimed in ORA, to the satisfaction of the Commission as explained below, have been rejected as 'incomplete'. However, a few candidates, who have claimed relevant experience but have not submitted the proper EC for full period of current job, have also been shortlisted subject to their submitting EC for the full period in due course.</p> <p>(vi) Experience certificates are to be in prescribed proforma in terms of R(C&P)'s circular No. F.8/84/2010-R (C&P) dated 23.12.2010. However, wherever the applicants have not submitted experience certificates in prescribed proforma, their experience certificate have been considered on merit.</p> <p>(vii) Appointment letters, office orders, resignation letters, pay certificates, service certificates and the certificates attested by the candidates themselves or self employment certificates have not been considered as proof of experience. Such candidates have also been considered as lacking relevant experience but rejected under 'Incomplete' Or 'LEQ- B' category as deemed fit.</p> <p>(viii) Some of the candidates can be rejected under more than one category. They have been rejected under the category considered as most appropriate.</p> <p>Note:- Modalities are decided by the Commission on case to case basis.</p>
