ESSENTIAL QUALIFICATIONS(EQs):

A. EDUCATION-

(i) A basic University or equivalent qualification included in any one of the Schedules to the Indian Medical Council Act, 1956 (102 of 1956) and must be registered in a State Medical Register or Indian Medical Register.

(ii) M.S.(Surgery)/ M.S.(General Surgery) from a recognized University/ Institution or equivalent.

B. Experience- Three years' teaching experience in the concerned Specialty after acquiring postgraduate qualification as Lecturer/ Registrar/ Senior Resident/ Demonstrator/ Tutor in a Recognized Medical College/ Teaching Institution.

The total numbers of effective applications is 20. All the applications have been considered.

MODALITIES:

- (i) Scrutiny has been done on the basis of the scrutiny report generated by the Computer System as per the information by the candidates in their online applications form and the documents certified uploaded with Online Recruitment Application.
- (ii) Experience as Part time/ hourly basis/ daily wages/ visiting / Guest faculty/ Apprentice/ Trainee/ GET/ Consultant/ Honorary/ Self-employed and stipendiary has not been counted while counting

experience. However, Experience on contract basis has been considered for scrutiny.

- (iii) Total experience claimed by the candidates in the relevant field has been taken into consideration. If supported by the necessary certificates.

➤ **Short-Listing Criteria:** EQA(i) + EQA(ii) + EQ(B)

1. The initial scrutiny details for the same were uploaded to the Commission website on 01/12/2023 and rejected candidate were asked to represent against their rejection within 10 days to the Commission. However, a list of provisionally shortlisted candidates was also uploaded to submit the requisite documents to the Commission within the same time limit.
2. One candidate (Roll No: 12) was asked to submit the deficient documents who was provisionally shot-listed and the same has not responded. Hence the candidature of Roll No. 12 is rejected under the category LEQ-A(i).
3. 02 representations (**Roll Nos. 07 & 20**) were received against their rejection and 01 representation (**Roll No. 07**) has been examined and consequently has been shortlisted.
4. 01 candidate **Roll No. 20** who has represented against his rejection is not found eligible. Therefore, rejection of Roll No. 20 is maintained. The representation of **Roll Nos. 20** is examined as under:
