ESSENTIAL QUALIFICATIONS(EQs):

A. EDUCATION-

(i) A recognized MBBS degree qualification included in the First Schedule or Second Schedule or Part II of the Third Schedule (other than licentiate qualifications) to the Indian Medical Council Act, 1956. Holders of Educational qualifications included in Part II of the Third Schedule should also fulfil the conditions specified in sub-section (3) of section 13 of the Indian Medical Council Act, 1956.

(ii) Post-Graduate degree/Diploma in the concerned specialty mentioned in Section-A or Section-B in Schedule VI or equivalent i.e. M.S. (Ophthalmology)/D.O. (Diploma in Ophthalmology/M.D. (Ophthalmology)/ D.O.M.S. (Diploma in Ophthalmic Medicine & Surgery).

(B) EXPERIENCE: Three years' experience in the concerned Specialty after obtaining the first Post Graduate degree or Five years' experience after obtaining the first Post Graduate diploma.

The total numbers of effective applications is 103. All the applications have been considered.
