	(i) Matriculation/Higher Secondary Certificate/Mark sheet showing date of birth.
	(ii) Caste Certificate (for SC/ST/OBC candidates) & EWS Certificate in prescribed format. OBC certificate should not be more than three years old. OBC certificate issued prior to 01.04.2021 has not been accepted. EWS certificate valid for 2023-24 has been considered relevant. Some of the candidates have furnished the SC/ST certificate without mentioning the residential para or residential para is left blank. These certificates have been treated as relevant certificate.
	(iii) Degree/Provisional certificate alongwith marksheet/final marksheet of a recognized University as mentioned in Advt. No. 12/2023, Vacancy No. 23061202624. The candidate possessing Bachelor's Degree/Post Graduate Degree in Aeronautical Engineering has been considered relevant EQ.
	Degree/PG Degree in Aerospace Engineering, Aircraft Maintenance Engineering is considered relevant E.Q for the above post as per All India Council for Technical Education Notification. PG Degree in Avionics has also been considered relevant EQ for the post. (a) Ministry of Education Letter No. F.18-1/78-T-7 dated 02.08.1978 certified that "a pass in the Associate Membership Examinations, Parts II and III/Section A & B, of the Aeronautical Society of India has been recognized at par with a Bachelor's Degree in Aeronautical Engineering from an Indian University for purposes of recruitment to superior posts and services under the Central Government.

Note: As per Public Notice of All India Council for Technical Education (Copy enclosed), MHRD, Govt. of India, through an order (vide OM No. 11-15/2011-AR (TS.II) dated 06.12.2012) withdrew the recognition granted to all certificates/qualifications awarded by professional bodies/institutions in the field of technical education. Accordingly, the Council decided to recognize equivalence for all purpose including Higher Education & Employment to Technical Courses conducted by various Professional Bodies/Institutions which were duly recognized by MHRD with permanent recognition upto 31.05.2013. Thus all those students who were enrolled with these institutions with permanent recognition upto 31.05.2013, stand recognized.

The Essential Qualification for the post is "A Degree in Aeronautical Engineering from a recognized University." Since in the EQ, there is no mention of equivalent Degree. Therefore, the candidates who have furnished the 'Section A & B of Associate Membership Examination from the Aeronautical Society of India' in support of their EQ, is not considered relevant for the post.
