Rajasthan	i) Making OSM Answer Booklet available to candidates online: As evaluation of four written papers of RAS MAIN 2013 exam was done through On Screen Marking (OSM) process, so RPSC was of view to provide these answer booklets to the candidate in online format to not only save the printing cost/ photocopy cost of answers booklet, delays and many other issues for manual process but also the copies are available online, on candidate request at their door step as they can download the same once they have made the payment online. For this, RPSC developed Answer Copies Download application and integrated it with the RPSC official portal where candidates can log-in and provide their credentials and an OTP is sent to candidate's registered mobile number to verify and after verification candidates may pay Rs. 50/- per answer booklet through payment online or through e-Mitra/CSC kiosks available across the State and once payment being made he/she can download the copies from the portal of answer booklets of exam papers, he/she selected and made the payment. Presently RPSC followed the process to provide copies only to those candidates who have applied these answer copies through RTI. It is a unique feature of this application where all such exams copies will be easily made through RPSC portal online.
		ii) One Time Registration (OTR): Although many commission thought of going for One Time Registration (OTR) and Some of the commissions are able to achieve this. RPSC was pioneer to provide this idea in 2011-12 and the same was also communicated in National Chair Persons Conference in Feb. 2012 at RPSC. To have this concept implemented in very effective way RPSC has taken few years to make the process easy and simple so that candidates applying for Government Recruitments should have a platform where he/she can register him/ herself only once for any Government department. To achieve this RPSC jointly worked with State Government IT Department to come up the State Recruitment Portal where not only RPSC, but also other government department data is to maintained. In this State Recruitment Portal, One Time Registration (OTR) is the process of registering and making profile of candidates who are interested to appear in any forthcoming exams. This process of registeration and profile creation will be a one-time process meaning that once registered candidate do not have to submit basic personal and educational details again and again for applying in different exams. Special mention is that, the OTR is integrated with Aadhaar database so that there is no duplicity of candidate data and in State of Rajasthan. Further, candidates have also been provided facility

		through e-Vault of State, where he/she may be uploaded all relevant
		documents, which may be required for verification purposes. At present the RPSC is awaiting for Government Sanction on the project with

In these 31 recruitments, the total number of candidates who have applied were 1510884 and who have appeared for the written exams. were 998611. The Commission also finalized 8 recruitments and selected 846 candidates out of 883 posts, in these recruitments, the entire process is completed within the above short period only. A significant factor to note is that most of these examinations are Computer Based Tests, and in a single session. Large number of candidates appeared in the examination. A sheet giving details of examinations (CBT) conducted is attached herewith. The Commission also implemented a scheme of publishing keys immediately after examinations, calling for objections in prescribed format, referring them to experts and there-after publishing final keys and marks. A high degree of transparency is achieved in this manner.
