VACANCY CIRCULAR

Sub: Filling up one vacancy in the Grade of Dispatch Rider(General Central Service, Group-‘C’ Non-Gazetted, Non-Ministerial) in the PB-1 [Rs.5200-20200/-] plus Grade Pay Rs. 1900/- in the office of UPSC on Deputation/absorption basis -reg.

It is proposed to fill up one vacancy in the Grade of Dispatch Rider(General Central Service, Group-‘C’ Non-Gazetted, Non-Ministerial) in the PB-1 [Rs.5200-20200/-] plus Grade Pay Rs. 1900/- in the office of UPSC on Deputation/absorption basis.

2. Eligibility Conditions: Deputation/Absorption

Officials of Central Government –

- (a) (i) holding analogous posts on regular basis ; or
(ii) With three years regular service in posts in the pay band-1 of Rs. 5200-20200/- with Grade Pay of Rs. 1800/- or equivalent

(b) **Possessing following educational qualifications-**

Essential:-

Possession of a valid driving licence for driving a three wheeler auto rickshaw, delivery van or any other vehicle

Desirable:-

Middle school pass certificate from a recognized school

3. Regulation of pay and other terms of deputation:

The pay of the selected candidate will be regulated under the provisions contained in the DoP&T O.M. No. No. 6/8/2009-Estt.(Pay II) dated 17/06/2010 as amended time to time.

4. Age-limit:

The maximum age-limit for appointment by deputation (including short-term contract/transfer) shall be not exceeding 56 years as on the closing date of receipt of applications.

5. Period of deputation:

Period of deputation including period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other organization/ Department of the Central Government shall ordinarily not exceed three years.

6. Reservation for SC/ST:

No provision for reservation exists for the posts to be filled up on deputation/absorption basis.

7. Application (in duplicate) only in the prescribed proforma (Annexure-I) of the eligible candidates whose services can be spared immediately on selection, together with the certificate from the Forwarding Authority (in proforma Annexure-II) along with the following documents:

- (i) Integrity certificate
(ii) List of major/ minor penalties imposed if any, on the official during the last 10 years; (if no penalty has been imposed a ‘Nil’ certificate should be enclosed).
(iii) Vigilance clearance certificate.
(iv) Attested photocopies of the ACRs for the last five years (2010-11 to 2014-15) (attested on each page by an officer not below the rank of an Under Secretary to the Govt. of India) (**wherever applicable**).

The required documents mentioned at the end of Annexure along with relevant documents in support of qualifications and experience, may be forwarded to **Sh.
