4.2 The result is further subject to the final outcome of the SLP No. 30621/2011 and 31288/2017, which are pending before the Hon'ble Supreme Court of India in the matter of 'reservation in promotion' and 'own merit' and any other pending Court case(s) having a bearing on the result of the Examination before any court of law.
