ESSENTIAL QUALIFICATIONS(EQs):

A.EDUCATIONAL

- (i) A basic University or equivalent qualification included in any one of the Schedules to the Indian Medical Council Act, 1956 (102 of 1956 and must be registered in a State Medical Register or Indian Medical Register.
- (ii) M.D.(Obstetrics & Gynaecology) / M.S.(Obstetrics & Gynaecology) from a recognized University / Institution or equivalent.
- **B. EXPERIENCE-** Three years' teaching experience in the concerned Specialty after acquiring postgraduate qualification as Lecturer/ Registrar/ Senior Resident/ Demonstrator/ Tutor in a Recognized Medical College/ Teaching Institution.

The total numbers of effective applications is 14. All the applications have been considered.

MODALITIES:

- (i) Scrutiny has been done on the basis of the report generated by the Computer System as per the information filled in by the candidates in the Online Recruitment Application (ORA) form and the documents/certificate uploaded with the ORA.
- (ii) Experience acquired as Part time/ hourly basis/ daily wages/ visiting / Guest faculty/ Consultant/ Honorary/ Self-employed and stipendiary has not been counted while counting experience. However, experience on contract basis in the relevant field and experience after obtaining MD degree and while pursuing the higher degree has been considered for scrutiny.
- (iii) Total experience claimed by the candidates in the relevant field has been taken into consideration. If supported by the necessary certificates.
- (iv) The application received from the Category other than General Category has been considered in the general category as post is reserved only for the UR category.
- (v) Based on the above facts the following criterion has been adopted for short listing.

Final Short-Listing Criteria: EQ(A) (i) & (ii)+EQ(B)

- 1. The scrutiny details for the same were uploaded to the Commission website on 26.02.2024 and rejected candidates were asked to represent against their rejection within 10 days to the Commission. However, a list of provisionally shortlisted candidates was also uploaded to submit the requisite documents to the Commission within the same time limit.
- 2. Total 05 candidates (Roll No. 02, 03, 08, 09 & 13) were asked to submit the documents and reply from candidates having Roll No. 02 & 03 have been received so far and consequently have been shortlisted
- 3. Remaining 03 candidates (Roll No. 08, 09 & 13) who have not responded, their rejection is maintained.
- 4. 06 candidates Roll No.01, 04, 06, 07, 11 & 14, who initially rejected were asked for representation, if any. Out of them, Roll No.01, 06, 11 & 14 have represented against their rejection which are not found eligible & 02 candidates having Roll No. 04 & 07) have not raised any representation. Therefore, rejection of these 04 candidates is maintained. The representation of these 04 candidates are examined as under.
