ESSENTIAL QUALIFICATIONS(EQs):

(A) EDUCATIONAL:

- (i) A recognized MBBS degree qualification included in the First Schedule or Second Schedule or Part II of the Third Schedule other than licentiate qualifications to the Indian Medical Council Act, 1956. Holders of Educational qualifications included in Part II of the Third Schedule should also fulfill the conditions specified in sub-section 3 of section 13 of the Indian Medical Council Act, 1956.
- (ii) Post-Graduate Degree in the concerned speciality or super speciality mentioned in Section A in Schedule VI or equivalent i.e. D.M. Medical Gastroenterology/ D.M. Gastroenterology/ M.D. Medicine or M.D. Paediatrics with 2 years special training in Gastroenterology.

(B) EXPERIENCE:

Three years' experience in the concerned Speciality after obtaining the first Post Graduate degree.

NOTE- 1: In case of holders of DM qualifications of 5 years' duration, the period of senior PG residency rendered in the last part of the said DM shall be counted towards requirement of experience.

NOTE- 2: The qualifications are relaxable at the discretion of the commission, for reasons to be recorded in writing, in case of candidates otherwise well qualified.

NOTE- 3: The qualifications granted in United Kingdom shall be recognized medical qualifications only when granted on or before 11.11.1978.

The total numbers of effective applications is 07. All the applications have been considered.

Modalities:

- (1) Scrutiny has been done on the basis of the scrutiny report generated by the Computer System as per the information filled in by the candidates in the online application form and the documents certified uploaded with ORA.
- (2) Experience as Part time/ hourly basis/ daily wages/ visiting/guest faculty/ consultant/ honorary/ self employed and stipendiary has not been counted while counting experience. However experience on contract basis in relevant field and experience after obtaining MD/MS degree and while pursuing the higher degree, i.e. DM, has been considered for scrutiny.
- (3) Total Experience claimed by the candidates in the relevant field has been taken into consideration if supported by the necessary certificates.
- (4) Since there is no vacancy for other than UR, the candidate from other category have been considered in UR category with raised criterion (if any) only.

The following criteria has been adopted for short listing the candidates:

For 01 (UR) Vacancy :

EQ-A(i) +EQ-A(ii) + EQ-B

1. The scrutiny details of the recruitment case were uploaded on the website of the Commission on 29th May, 2024. Subsequently, the candidates were given a window to raise their representations through email within 10 days till 08/06/2024.

2. In the initially uploaded short-listing criteria, there were two candidates (Roll No. 04 & 06) rejected under **LEQ-A** and three candidates (Roll No. 01, 02 & 03) were provisionally short-listed under CFD. However only one candidate (Roll No. **01**) responded who was shortlisted under CFD, sent his deficient document (i.e., **Matriculation Certificate**) and got provisionally shortlisted for interview.
