ESSENTIAL QUALIFICATIONS(EQs):

A. EDUCATION-

- (i) A recognized MBBS degree qualification included in the First Schedule or Second Schedule or Part II of the Third Schedule (other than licentiate qualifications) to the Indian Medical Council Act, 1956, (102 of 1956). Holder of educational qualifications included in Part II of the Third Schedule should also fulfill the conditions specified in sub-section (3) of section 13 of the Indian Medical Council Act, 1956 (102 of 1956).
- (ii) Post-graduate Degree or Diploma in the concerned speciality or Superspeciality mentioned in Section-A or Section-B in Schedule VI of CHS Rules, 2014 and CHS amendment Rules 2019 i.e. Doctor of Medicine(Pediatrics) or Diplomate National Board (Pediatrics) or Diploma in Pediatrics or Diploma in Child Health.
- **B. Experience** Three years' experience in the concerned Speciality or super-speciality after obtaining the first Post-graduate degree or 5 years' experience after obtaining the Post-graduate Diploma.

The total numbers of effective applications is 81. All the applications have been considered.

MODALITIES:

- (i) Preliminary Scrutiny has been done strictly in accordance with Essential Qualification prescribed for the post and the conditions laid down in the advertisement for the post.
- (ii) Scrutiny has been done online, first on the basis of the report generated by the Computer System as per the information filled up/claims made

therein by the candidates in their online applications and thereafter by scrutiny of the supporting documents uploaded along with the same only in respect of candidates whose applications are prima-facie found eligible on the basis of information filled up/claims made by them in the online applications.

- (iii)The candidates who do not possess the relevant essential educational qualifications have been rejected as "LEQ-A". Like-wise, if essential experience is not in the relevant field as specified, in the Recruitment Rules of the post or relevant experience is less than the required period, such candidates have been rejected under "LEQ-B".
- (iv)In the Advertisement, applicants were asked to upload all certificates/documents along with online applications; however, some applicants have not uploaded complete certificates/documents. Those candidates who have claimed essential qualifications and fulfill shortlisted criteria but have not uploaded relevant documents have been provisionally shortlisted and suggested to "Call for Documents (CFD)."
- (v) As the number of UR candidates were 49 for a single post, EQ(B) has been from 3 years & above to 6 years & above to rationalize the number of candidates around the prescribed limit.
- (vi) Experience acquired as Part time/ hourly basis/ daily wages/ visiting / Guest faculty/ Apprentice/ Trainee/ GET/ Consultant/ Honorary/ Self-employed and stipendiary has not been counted while counting experience. Experience on contract basis in the relevant field has been considered.

Short-Listing Criteria:

For Unreserved Post: EQA(i) + EQA(ii) + EQ(B) raised to 6 years and above after obtaining the first Post Graduate Degree or 8 years' after obtaining

the Post Graduate Diploma.

For OBC & SC Posts: EQA(i) + EQA(ii) + EQ(B)

- 3. Remaining 08 candidates (Roll No. 50, 51, 52, 55, 56, 60, 63 & 72) who have not responded, their rejection is maintained.
- 4. No representation received from the rejected candidate against their rejection for the subject post.
