- (i) A recognized MBBS degree
- (ii) M.D.(Forensic Medicine).

(B) EXPERIENCE: Three years' experience in the concerned Specialty after acquiring first postgraduate degree.

The total numbers of effective applications is 37. All the applications have been considered.

1. The scrutiny and short-listing details of this recruitment case were initially uploaded on the website of the Commission on 04.04.2024.

2. The candidates were given a window to express their concerns through email within 10 days.

3. Following short-listing criteria has been adopted to shortlist the candidates for interview:

Criterion: **EQ-A(i) + EQ-A(ii) + EQ-B**

4. Since some of the candidates had not uploaded complete documents while filling online application, 11 candidates bearing roll nos. 02, 06, 09, 11, 12, 15, 21, 22, 26, 28, 34 & 36 were provisionally shortlisted, who were asked to furnish copies of the deficient documents/relevant certificates. Out of these, only 06 candidates bearing roll no. **06, 15, 22, 28, 34 & 36 have been found eligible to be shortlisted** for interview. Remaining 06 candidates bearing roll nos. 02, 09, 11, 12, 21 & 26 who have not responded have been rejected.

5. No candidate who was initially rejected has represented against his/her rejection.
