3. The scrutiny details were uploaded on the commission's official website 24/06/2024 giving an opportunity to rejected candidates to represent against their rejection by 04/07/2024.

4. E-mail Representation/CFD have been received from 06 candidates till 10/07/2024 and these have been examined. All the applications in the ZoC have been re – examined. The emails and representations have been re-examined with reference to the on-line applications, the educational qualifications and supporting documents received along with the ORA and the modalities & Criteria adopted by the commission. Accordingly, the following are the consequent observations and proposals as tabulated below:

3.	08	i.10th Certificate for DoB proof. ii.Master Degree Certificate in Music.	The candidate had already submitted the 10 <sup>th</sup> class Mark sheet online as a proof of Date of Birth and has submitted the called for Master Degree Certificate in Music and UGC-NET Certificate. <b>Therefore, she may be shortlisted.</b>

		iii. Proof of NET clearance conducted by UGC/CSIR.	
4.	10	10th Certificate for DoB proof.	The candidate has submitted a copy of the called for 10 <sup>th</sup> Certificate for Date of Birth proof. His Date of Birth as mentioned in 10 <sup>th</sup> Certificate is 03.08.1992. <b>Therefore, he may be shortlisted.</b>
5.	11	i. Affidavit for mismatch in the name of candidate's mother in 10 <sup>th</sup> Certificate. ii. Proof of NET clearance conducted by UGC/CSIR. <b>or</b> iii. Proof of Ph.D. Degree issued as per UGC Regulations, 2009 or 2016.	The candidate has submitted a copy of the called for UGC-NET Certificate. Although, she has not submitted an Affidavit justifying the missing surname of her mother in 10 <sup>th</sup> Certificate, the correct name of her mother is available in the UGC-NET Certificate submitted by her. <b>Therefore, she may be shortlisted.</b>
6.	16	i. Proof or certificate for CGPA 6.45 is equal to 55% or more. ii. Proof of NET clearance conducted by UGC/CSIR.	The candidate has submitted the called for UGC-NET Certificate and has informed that she has secured 1223 marks in Master of Arts (Music) out of total 2150 that comes to 56.88% marks. <b>Therefore, she may be shortlisted.</b>
<b>REPRESENTATION</b>			
7.	22	LEQ-A.	The Applicant in her online application as well as in her representation has not submitted a Master Degree in Music or Provisional passing Certificate in music. She has only submitted a consolidated final grade card in Vocal music with 80% marks and UGC-NET Certificate in Music. However, in her representation

			<p>she has assured to submit the same before the interview.</p> <p>As the Master Degree Certificate or Provisional Passing Certificate along with mark sheet in the relevant subject is a pre-requisite for selection of an Applicant for interview, <b>her application is rejected.</b></p>

As such, after examination of the e-mails/ representations, one candidate (Roll No. 04) who was earlier provisionally shortlisted, has been rejected because he has not submitted the copy of the called for documents. Provisionality of other candidates has been cleared. However, the explanations and justification given by the only one candidate (Roll No.22) has not been found satisfactory and do not provide sufficient and convincing ground for short listing by revising and reversing the initial decision of the Commission. As such, her rejection is maintained.
