#### 1. **Earnest Money Deposit**

- 1.1 Earnest Money Deposit of Rs. 20,000/- (Rupees Twenty thousand only) in the form of Demand Draft/Pay order/ Bankers' Cheque drawn in favour of Secretary, UPSC must be delivered to the UPSC on or before bid opening date/time as mentioned in critical date sheet. The bidder shall online submit a self Attested Scanned copy of EMD
- 1.2 The EMD should remain valid for a period of 45 days beyond the final tender validity period.
- 1.3 Bidders shall not be permitted to withdraw their offer or modify the terms and conditions thereof. In case the bidder fails to observe and comply with the stipulations made herein or backs out after quoting the rates, the aforesaid bid security shall be forfeited to the Government.
- 1.4 The bids without Earnest Money shall be summarily rejected.
- 1.5 No interest shall be paid on the earnest money deposit.

#### 2. **Financial Bid:**

Scanned copy of Financial Bid should be uploaded, in the prescribed format as per Annexure-I. Unstamped and /or unsigned bids will not be entertained.

#### 3. **Evaluation of Bid:**

The evaluation of bid will be done by a Tender Evaluation Committee (TEC) constituted for this purpose. The tender will be awarded to the firm who quote highest rate and fulfils all the terms and Conditions of NIT.

#### 4. Terms & Conditions

- 4.1 The Bidders should quote their unconditional rates for whole items and not individually as per the enclosed prescribed Performa (Annexure-I).
- 4.2 Bids are invited only from the registered firms dealing with E-waste & bids received from the firms other than registered will be summarily rejected. The tenderers/Authorized E-waste Recyclers shall have to submit the Authorization Certificate obtained from the Govt. of India/State Government in their own name/organization for collection/disposal of E-Waste items for Computers, Printers, UPS and its peripherals, Electrical/Electronics items etc.
- 4.3. Bids should remain valid for acceptance for a period of six months from the date of opening of the Bids. Bids with lesser validity period will be summarily rejected.
- 4.4 Materials should be removed by the highest acceptable responsive bidder (H-I) on "as is where is" basis within five days of receipt of order after depositing the full amount with the Cashier of the Commission in the form of Crossed Bank Draft/Pay Order/Banker's Cheque drawn in favour of the Secretary, Union Public Service Commission, New Delhi. Amount of EMD may be adjusted against the final payment on the request of the successful bidder or EMD shall be returned after the condemned material is removed as per terms & conditions laid down. In case, the material is not removed within the prescribed time, the Earnest Money will be forfeited and any loss whatsoever occurring due to this will be recovered from the bidder.

- 4.5 The inspection of material should be done carefully by the prospective bidders or their representatives in this office premises between 3:00 PM to 4:00 PM on 02.04.2018 to 06.04.2018 and queries raised to the concerned officer at the time of inspection. No further clarifications shall be given after the above inspection.
- 4.6 No damage should be caused to the existing property of the Commission or the Govt. while removing the auctioned articles from the site. Any loss/damage to the Govt. /Commission or injury or personal accident suffered by any person due to the negligence or action of the successful bidder or his authorized worker/supervisor will have to be indemnified by the successful contractor.
- 4.7 Goods/material will be removed under the supervision of designated officer(s) of the Commission. Materials will have to be removed within 5 days from the receipt of order. No extension in time will be given under ordinary circumstances. Addl. Secretary, UPSC may however, allow an extension up to another 2 days provided full reasons for causing such delay is given in writing by the Contractor. Delay, beyond the stipulated time, may entitle UPSC to cancel the award/order and forfeit the EMD of the contractor.
- 4.8 Goods/material will be allowed to be removed only during working hours. The articles will not be allowed to be removed on holidays or after working hours. The successful bidder will have to take away all Condemned listed items and not selectively.
- 4.9 All the bidders shall ensure compliance with the provisions contained in E-Waste (Management) Rules-2016 and guidelines issued by the Govt. for disposal/recycling in an environment friendly manner and any other notifications notified thereafter by the Govt. Of India/State Govt./ Union Territory.
- 4.10 All questions, disputes or differences arising under and out of or in connection with the disposal of condemned items, shall be referred to sole arbitration by an arbitrator appointed under the provisions of Indian Arbitration Act by Secretary, UPSC.
- 4.11 Secretary, Union Public Service Commission, reserves the right to accept or reject any or all the tenders. The bidders may send his representation, addressed to the Secretary, in case he feels that proper procurement process has not been followed and/or his tenders has been rejected wrongly.
