NATIONAL DEFENCE ACADEMY & NAVAL ACADEMY EXAMINATION (II) 2023.

The Union Public Service Commission will be conducting the National Defence Academy and Naval Academy Examination (II) 2023 at various Centers/Venues all over India on O3rd September, 2023 (Sunday). The Commission has uploaded the e-Admit card for the convenience of the admitted candidates on the Commission's web-site (https://upsconline.nic.in). The admitted candidates are advised to download their e-Admit Cards for the Examination and take a printout thereof. The admitted candidates will have to produce the printout of their e-Admit Card at the allotted Venue for appearing in the Examination, along with Photo Identity Card mentioned in the e-Admit Card.

In case, the photograph is not visible/blurred or not available on the e-Admit Card, candidates are advised to carry **two (2) identical photographs (one photograph for each session).** No paper Admit Card will be issued for the Examination by the Commission. In case of any discrepancy is noticed in the e-Admit Card, the same may be communicated to the Commission immediately at e-mail ID <u>usnda-upsc@nic.in</u> latest by 23th August, 2023 to enable the Commission to take a decision in the matter.

The Candidates are advised to take a printout of the e-Admit Card well in advance to avoid last minute rush. "Important Instructions to the candidates" must be read carefully by the candidates.

It may also be noted that entry into the Examination Venue shall be closed 10 minutes before the scheduled commencement of the Examination i.e. 09.50 A.M. for the Forenoon Session and 01.50 P.M. for the Afternoon Session. No candidate shall be allowed the entry into the Examination Venue after closure of the entry.

Candidates should also note that they shall not be allowed to appear at any other Examination Venue except the Examination Venue mentioned in the e-Admit Card.

Candidates are also advised to bring **Black Ball Point Pen** as the candidates shall be required to fill the Attendance List and the OMR Answer Sheet with **Black Ball Point Pen** only.

Candidates may submit representations, if any, on the questions asked in the Question Papers of this Examination to the Commission through the "Online Question Paper Representation Portal (QPRep)" only by accessing the <u>URL:</u> https://upsconline.nic.in/miscellaneous/QPRep/ within a period of Seven (07) days from the date of Examination. No representation through any other mode and received after the above period shall be accepted by the Commission.

Keeping in view the improved situation of Covid-19, the wearing of mask by candidates and examination functionaries has been made optional. Further, the instructions/guidelines/protocols issued from time to time by the GOI/State authorities in respect of Covid-19 disease are to be followed scrupulously. Candidates are allowed to bring their own hand sanitizer in transparent bottles. Besides above, candidates have to follow COVID-19 norms of "Social distancing" as well as "Personal hygiene" inside the Examination Halls/Rooms as well as in the premises of the Venue.

Mobile phone (even in switched off mode), pager or any electronic equipment or programmable device or storage media like pen drive, smart watches etc. or camera or Bluetooth devices or any other equipment or related accessories either in working or switched off mode capable of being used as a communication device are banned inside the Examination Hall. Any infringement of these instructions shall entail disciplinary action against the concerned candidate including debarment from future Examination/ Selection.

Valuable/ costly items and bags are also not allowed inside the Examination Venue.
