(ii) M.D.( Obstetrics & Gynaecology)/ M.S.( Obstetrics & Gynaecology) from a recognized University/ Institution or equivalent.

B. EXPERIENCE Three years' teaching experience in the concerned Specialty after acquiring postgraduate qualification as Lecturer/ Registrar/ Senior Resident/ Demonstrator/ Tutor in a Recognized Medical College/ Teaching Institution.
