CENTRAL ARMED POLICE FORCES (ACs) EXAMINATION, 2021

The Result of the Central Armed Police Forces (ACs) Examination, 2021 was declared vide Press Note dated 02.06.2023 recommending 151 candidates in the order of merit for appointment.

2. The Commission, in accordance with Rule 16 (4) & (5) of the Central Armed Police Forces (ACs) Examination, 2021, had also maintained a Reserve List in order of merit below the last recommended candidate.

3. The Commission hereby recommends following 19 candidates (General-10, EWS-02, OBC-07) to fill up the remaining posts based on Central Armed Police Forces (ACs) Examination, 2021. A list of these candidates is enclosed. Ministry of Home Affairs would be communicating directly with recommended candidates.

4. The Candidature of Roll Number (s) 0405713 is provisional and candidature of one candidate is kept withheld.
