**CIVIL SERVICES (MAIN) EXAMINATION, 2022**

**Date: 01-11-2023**

The result of the Civil Services (Main) Examination, 2022 was declared vide Press Note dated 23.05.2023 recommending 933 candidates in order of merit for appointment to IAS, IFS, IPS and certain other Central Services, Group 'A' and Group 'B' against 1022 vacancies.

2. The Commission, in accordance with the Rule 20 (4) & 20 (5) of the Civil Services Examination Rules, 2022 has also maintained a Consolidated Reserve List in order of merit below the last recommended candidate under the respective categories.

3. As sought by the Department of Personnel & Training, the Commission has now recommended 89 candidates which include 65 General, 7 EWS, 15 OBC, 1 SC and 1 ST, to fill up the remaining posts based on the Civil Services Examination, 2022. Particulars of these candidates are included herewith. The candidates, so recommended, will be intimated directly by the DOP&T.

4. The candidature of following 2(two) candidates bearing Roll No. 3534972 and 0828156 are provisional.
