ESSENTIAL QUALIFICATIONS(EQs):

(A) EDUCATIONAL:

- (i) Degree in Ayurveda Medicine from a University established by law or statutory board/faculty/examining body of Indian Medicine or equivalent as recognized under Indian Medicine Central Council Act 1970.
- (ii) A Post Graduate Degree in the subject/specialty concerned included in the schedule of Indian Medicine Central Council Act 1970.

The total number of effective applications is 17. All the applications have been considered.

Modalities:

- (1) PS has been done on the basis of the Scrutiny Report generated by the Computer System as per the information filled in by the candidates in the online application form and the documents/certificate uploaded with the ORA.
- (2) In the Advertisement, applicants were asked to upload all certificates/documents along with Online Applications; however, many applicants have not uploaded complete certificates/documents.
- (3) Since there are sufficient candidates are available in the specialty of Panchkarma, the allied specialty 'Kayachikitsa' has not been considered.
- (4) Experience acquired as Part time/ hourly basis/ daily wages/

visiting/Guest faculty/ Apprentice/ trainee/GET/ Consultant/ Honorary/ Self-employed and stipendiary has not been counted while counting experience. Experience on contract basis in the relevant field has been considered.

The following criteria have been adopted for shortlisting of the candidates:

1. The Scrutiny and short-listing details of this recruitment case were initially uploaded on the website of the Commission on 03/08/2022.
2. The candidates were given a window to express their concerns through email by 17/08/2022.
3. A total 2 representations have been received and have been re-examined.
