- It was also mentioned that all the e-mails will be examined but none of them would be responded to as indicated earlier. It was further assured that the revised scrutiny and shortlisting details would be uploaded in due course.
- Representations have been received from 07 applicants. They have been examined.
- 05 applicants under “**LEQ-(B)**” category, 01 applicant under “**Incomplete - Incomplete EC**” category and 01 applicant under “**Incomplete - No EC**” category have represented against their rejection. Out of these, 03 applicants have been shortlisted to be called for interview. Rejection of other candidates has been maintained. However, the rejection category of a candidate who was earlier rejected under the category “**Incomplete - Incomplete EC**” has now been changed to “**LEQ-B**”.

However, wherever the applicants have not submitted experience certificates in prescribed proforma, their experience certificate have been considered on merit.</p> <p>v. Appointment letters, office orders, resignation letters, pay certificates, service certificates and the certificates attested by the candidates themselves or self-employment certificates have not been considered as proof of experience. Such candidates have also been considered as lacking relevant experience but rejected under 'Incomplete' or 'LEQ-B' category as deemed fit.</p> <p>vi.
