ESSENTIAL QUALIFICATIONS(EQs):

(A) EDUCATIONAL:

- (i) Degree in Unani of a recognized University or Statutory State Board/Council of equivalent recognized under the Indian Medicine Central Council Act, 1970 (48 of 1970).
- (ii) Enrolment in State Register or Central Register of Unani.

The total numbers of effective applications is 198. All the applications have been considered.

Modalities:

- (1) PS has been done on the basis of the Scrutiny Report generated by the Computer System as per the information filled in by the candidates in the online application form and the documents/certificate uploaded with the ORA.
- (2) In the Advertisement, applicants were asked to upload all certificates/documents along with Online Applications; however, many applicants have not uploaded complete certificates/documents.
- (3) Experience acquired as Part time/ hourly basis/ daily wages/ visiting/Guest faculty/ Apprentice/ trainee/ Consultant/ Honorary/ Self-employed and stipendiary has not been counted while counting experience. Experience on contract basis in the relevant field has been considered.
