ESSENTIAL QUALIFICATIONS(EQs):

(A) EDUCATIONAL:

- (i) MBBS Degree
- (ii) Post-Graduate degree in the concerned speciality or super speciality from a recognised institute.

(B) EXPERIENCE: At least three years' teaching experience as Senior Resident or Tutor or Demonstrator or Registrar or Assistant Professor or Lecturer in the concerned Specialty or Super Specialty in a recognized teaching institution after obtaining the first Post Graduate degree.

The total numbers of effective applications is 148. All the applications have been considered.

The scrutiny details for the case are as under:

The following Short-Listing Criteria has been adopted:

EQ(A) +EQ(B) enhanced to 3 years 3 months for UR candidates
EQ(A) +EQ(B) for all the remaining categories

1. The scrutiny and short-listing details of this recruitment case were initially uploaded on the website of the Commission on 29/09/2022.
2. The candidates were given a window to express their concerns through email within 15 days.
3. A total of 17 representations have been received and all of them have

been examined.

4. One candidate bearing Roll No. 132 has represented against his rejection under LEQ-B(Lacking Essential Criteria- Experience) category. His representation along with his application dossier has been examined and it is observed that the experience certificates along with the claims made in the online application of the candidate do not establish the essential experience criteria of 3 year duration and hence his rejection is maintained

5. 14 candidates (Roll No. 05, 12/13, 17, 26, 31, 33, 38, 45, 69, 70, 72, 89, 101 & 104) have represented against their rejection under LEC(Lacking Enhanced Criteria- Experience) category. Their representations along with their application dossiers have been examined and it is observed that the experience certificates along with the claims made in the online application of only 03 candidates bearing roll no. **26, 72 & 101 establish the enhanced essential experience criteria of 3 year 3 months' duration and hence they are shortlisted.** Remaining candidates have not been found suitable to be shortlisted and hence their rejection is maintained.

6. 02 candidates (Roll Nos. **40 & 50**) have represented against their rejection under "Incomplete application due to non-submission of deficient documents or submission of unsatisfactory documents in response to our Email". Their representations along with their application dossiers have been examined and it is observed that both the candidates have all the eligibility required for the said post and hence **are shortlisted.**
