(A) EDUCATIONAL:

- (i) Degree in Ayurveda Medicine from a University established by law or statutory board/faculty/examining body of Indian Medicine or equivalent as recognized under Indian Medicine Central Council Act 1970.
- (ii) A Post Graduate Degree in the subject/specialty concerned included in the schedule of Indian Medicine Central Council Act 1970.

The total number of effective applications is 107. All the applications have been considered.

Modalities:

- (1) PS has been done on the basis of the Scrutiny Report generated by the Computer System as per the information filled in by the candidates in the online application form and the documents/certificate uploaded with the ORA.
- (2) In the Advertisement, applicants were asked to upload all certificates/documents along with Online Applications; however, many applicants have not uploaded complete certificates/documents.
- (3) Since the number of candidates are large i.e. 107 for 01 UR post and to restrict the number of applicants, 05 years experience in teaching and

clinical is proposed to be enhanced for 01-UR post. Applications received from SC, ST, EWS & OBC category candidates may be treated at par with General candidates.

(4) Experience acquired as Part time/ hourly basis/ daily wages/ visiting/Guest faculty/ Apprentice/ trainee/GET/ Consultant/ Honorary/ Self-employed and stipendiary has not been counted while counting experience. Experience on contract basis in the relevant field has been considered.

The following criteria have been adopted for shortlisting of the candidates:

EQ-A(i) + EQ-A(ii) + raised by 05 years teaching/clinical experience after PG.
