- (b) Two years' experience in Occupational Therapy/ Rehabilitation, Planning, Implementation of research projects in Institute or Community level from an institute recognized by the Central or State Government or an autonomous body under the Central or State Government or a University recognized by the University Grant Commission or an institute recognized by the Regulatory Council.
