- (ii) Post-Graduate degree in the concerned speciality or super speciality mentioned in Section A of Schedule VI from recognized Teaching Institute i.e. Doctor of Medicine (Social and Preventive Medicine); or Doctor of Medicine (Community Medicine); or Doctor of Medicine (Community Health Administration); or Doctor of Medicine (Health Administration); or Diplomate National Board (Social and Preventive Medicine/Community Medicine/Community Health Administration/Health Administration).
