- (a) The scrutiny of the documents/certificates uploaded with online recruitment application was carried out and the details were initially uploaded on the Commission's website on 03 June 2022.
- (b) The candidates were given a widow to express their concerns through email by 20 June 2022.
- (c) Representations of **Total 02 (Two) (Roll No 13 & 48)** have been received and both of them have been examined as follows:-
 - (i) **Roll No 13.** As per DoPT guidelines, the age relaxation is granted to Govt servants appointed on regular basis by Central Govt, hence rejection maintained.
 - (ii) **Roll No 48** The experience claimed is not in the field of teaching/clinical for minimum 05 years, hence rejection maintained.
- **Essential Qualification**
- (a) Degree in Unani Medicine from a University established by law or statutory/Faculty/Examining body of India Medicine or equivalent as recognized under Indian Medicine Central Council Act 1970.
- (b) A Post Graduate Degree in the subject/specialty concerned included in the schedule of India Medicine Central Council Act 1970.
- **Modalities**
- (a) Scrutiny has been done on the basis of the scrutiny Report generated by the Computer system as per information filled in by the candidates in the online application form and the documents/certificate uploaded with ORA.
- (b) Applications received from SC, OBC & EWS category have been treated **at par** with General candidates. Experience has been enhanced to 05 years in teaching and clinical experience for the post after PG degree.
- (c) Experience acquired as Part time/hourly basis/daily wages/visiting/Guest faculty/Apprentice/ trainee/consultant/Honorary /Self-employed and stipendiary has not been counted while counting experience. Experience on contract basis in the relevant field has been considered.
- (d) The scrutiny of the application has been done strictly as per the provisions of Recruitment Rules (RRs) for the post in question.
- (e) Total experience claimed by the candidates in the relevant field has been taken into consideration, if supported by necessary certificates.
- (f) The candidates who do not possess 05 years experience in relevant field is rejected under lack of Enhanced Criteria 'LEC'.
- (g) If experience is not in the relevant field as enhanced to 05 years in teaching and clinical experience for the post after PG degree, such candidates have been rejected 'ZOC'.
