I. A (i) A basic University or equivalent qualification included in any one of the Schedules to the Indian Medical Council Act, 1956 (102 of 1956) and must be registered in a State Medical Register or Indian Medical Register.

(ii) M.D. (Pharmacology)/ MBBS with Ph.D.(Medical Pharmacology) from a recognised University/ Institution or equivalent.

OR

B (i) M.Sc. (Medical Pharmacology) from a recognised University or equivalent.
(ii) Ph.D.(Medical Pharmacology)/ D.Sc.(Medical Pharmacology) from a recognised University/ Institution or equivalent.

II. Ten years' experience in the profession after acquiring Post Graduate qualification, out of which four years should be as Reader/ Associate Professor in a Recognised Medical College/ Teaching Institution.
