(ii)	<b>Desirable Qualification (DQ)- Nil</b>

Modalities adopted	(i) Based on information given in the online application form if supported by uploading necessary document/ certificates (ii) Experience has been given due weightage based on document / certificate uploaded. (iii) Research scholar / Ph.D degree holder have been given due weightage of three years if it is completed. Ongoing research have been given weightage bases on actual period of research. (iv) Experience certificate given in the commission's circular number F.8/84/2010-RC&P dated 23.12.2010 has been given preference. However, experience certificate in another format has been considered on merit. (v) Candidates not possessing essential qualification has been rejected as LEQ(A) and not possessing relevant experience has been rejected under LEQ(B). (vi) Teaching experience has not been considered relevant. Similarly, experience as 'Intern/training' has also not been considered relevant. (vii) Appointment letter, office order, registration certificate, relieving order, pay certificate have not been considered relevant proof of experience. (viii) Candidates who can be rejected under more than one category have been rejected under most appropriate category.
