ESSENTIAL QUALIFICATIONS(EQs):

A. EDUCATION-

- (i) A recognized MBBS degree qualification included in the First Schedule or Second Schedule or Part II of the Third Schedule (other than licentiate qualifications) to the Indian Medical Council Act, 1956 (102 of 1956). Holders of Educational qualifications included in Part II of the Third Schedule should also fulfill the conditions specified in sub-section (3) of section 13 of the Indian Medical Council Act, 1956 (102 of 1956).
- (ii) (ii) Post-Graduate degree in the concerned speciality or super speciality mentioned in Section A of Schedule VI from recognized Teaching Institute i.e. Doctorate of Medicine(Pulmonary Medicine); or Diplomate National Board (Pulmonary Medicine); or Doctor of Medicine(Respiratory Medicine/ General Medicine/Paediatrics) with two years' special training in Pulmonary Medicine; or Diplomate National Board(Respiratory Medicine/ General Medicine/Paediatrics) with two years' special training in Pulmonary Medicine.

(B) EXPERIENCE: At least three years' teaching experience as Senior Resident or Tutor or Demonstrator or Registrar or Assistant Professor or Lecturer in the concerned Specialty or Super Specialty in a recognized teaching institution after obtaining the first Post Graduate degree.

The total numbers of effective applications is 14. All the applications have been considered.

MODALITIES:

- (i) Scrutiny has been done on the basis of the scrutiny report generated by the Computer System as per the information by the candidates in their online applications form and the documents certified uploaded with Online Recruitment Application.
- (ii) Experience as Part time/ hourly basis/ daily wages/ visiting / Guest faculty/ Apprentice/ Trainee/ GET/ Consultant/ Honorary/ Self-employed and stipendiary has not been counted while counting experience. However, Experience on contract basis in relevant filed and experience in organizations mentioned above, while pursuing the post graduate (DM) or higher degree has been considered for scrutiny.
- (iii) Total experience claimed by the candidates in the relevant field has been taken into consideration. If supported by the necessary certificates.
- (iv) The applications received from the SC category have been considered in the general category only as post is reserved only for the UR and OBC category.
- (v) DM qualification of 3 years duration has been considered for 3 years teaching experience.
