A. EDUCATIONAL

- (i) A recognized MBBS degree qualification included in the First Schedule or Second Schedule or Part II of the Third Schedule (other than licentiate qualifications) to the Indian Medical Council Act, 1956 (102 of 1956). Holders of Educational qualifications included in Part II of the Third Schedule should also fulfill the conditions specified in sub-section (3) of section 13 of the Indian Medical Council Act, 1956 (102 of 1956).
- (ii) Post-graduate Degree or Diploma in the concerned Specialty of Super-specialty mentioned in Section-A or Section-B in Schedule VI of CHS rules i.e., Doctor of Medicine (Tuberculosis) or Doctor of Medicine (Tuberculosis and Respiratory Diseases) or Diplomate National Board (Tuberculosis)/ (Tuberculosis and Respiratory Diseases) or Doctor of Medicine (Medicine) with Diploma in Tuberculosis Diseases Doctor of Medicine (Medicine) with Diploma in Tuberculosis and Chest Diseases or Diplomate National Board (Medicine) with Diploma in Tuberculosis Diseases or Diplomate National Board (Medicine) with Diploma in Tuberculosis and Chest Diseases or Doctor of Medicine (Tuberculosis and Chest Diseases) or Diplomate National Board (Tuberculosis and Chest Diseases) or Post Graduate Diploma in Tuberculosis Diseases or Post Graduate Diploma in Tuberculosis and Chest Diseases.

B. EXPERIENCE Three years' experience in the concerned Specialty or super-specialty after obtaining the first Post-graduate degree or 5 years' experience after obtaining the Post-graduate Diploma.

Modalities:

- (ii) Experience as Part time/hourly basis/daily wages/visiting/Guest faculty/Consultant/Honorary/Self-employed and stipendiary has not been counted while counting experience. However, experience on contract basis in the relevant field and experience while pursuing the higher degree has been considered for scrutiny.
- (iii) Post Graduate Educational Qualification in pulmonary medicine, Respiratory Medicine, Tuberculosis & Respiratory disease, Tuberculosis as Chest Disease has been considered at par for short listing.
- (iv) Three years experience as DM specialty in Pulmonary, CCM and sleep medicine has been considered for the experience in the required specialty.

- (v) Total experience claimed by the candidates in the relevant field has been taken into consideration. If supported by the necessary certificates.
- (vi) The applications received from the SC category have been considered in the general category only as post is reserved only for the UR and OBC category.
- (vii) Based on the above facts the following criterion has been adopted for short listing;
