1. **ESSENTIAL QUALIFICATIONS:**

EDUCATION-

(i) A recognized MBBS degree qualification included in the First Schedule or Second Schedule or Part II of the Third Schedule (other than licentiate qualifications) to the Indian Medical Council Act, 1956. Holders of Educational qualifications included in Part II of the Third Schedule should also fulfill the conditions specified in sub-section (3) of section 13 of the Indian Medical Council Act, 1956.

(ii) Post-Graduate Degree/Diploma in the concerned speciality or super speciality mentioned in Section A or Section B in Schedule VI or equivalent i.e. M.D.(Dermatology)/ M.D.(Dermatology & Venereology)/ M.D. in Medicine with Diploma in Dermatology/ Diploma in Dermatology(D.D.).

Experience- Three years' experience in the concerned Specialty after obtaining the first Post Graduate degree or 5 years' experience after obtaining the first Post Graduate diploma.

The total numbers of effective applications is 42. All the applications have been considered.

2. **Modalities**

(a) Preliminary Scrutiny has been done on the basis of the Scrutiny Report generated by the Computer System as per the information filled in by the candidates in the online application form and the documents/certificate uploaded with the Online Recruitment Application.

(b) Experience acquired as Part time/ hourly basis/ daily wages/ visiting / Guest faculty/ Apprentice/ Trainee/ GET/ Consultant/ Honorary/ Self-employed and stipendiary has not been counted while counting experience. Experience on contract basis in the relevant field has been considered.

(c) Total experience claimed by the candidates in the relevant field has been taken into consideration, if supported by the necessary certificate.

- (d) OBC candidate having certificate from outside the Delhi have been considered in UR category with raised criterion only.
- (e) The SC/ST who are having less than minimum required experience have been considered under relaxed standard.
