**EDUCATIONAL:**

i) A recognized MBBS qualification included in the First or Second Schedule or Part II of the Third Schedule (other than licentiate qualifications) to the Indian Medical Council Act, 1956. Holders of educational qualifications included in Part II of the Third Schedule should also fulfill the conditions stipulated in sub-section (3) of section 13 of the Indian Medical Council Act, 1956.

ii) Post-graduate Degree in the concerned speciality mentioned in Section-A in Schedule VI or equivalent i.e., Doctor of Medicine (Medicine) or Doctor of Medicine (General Medicine).

**B. EXPERIENCE**

Three years, experience in the concerned speciality after obtaining the first Post Graduate Degree.
