- 4. The written result of SOs (Gr.'B') LDCE, 2019-2020 in respect of Category X is declared in accordance with the extant rules and regulations.
- 5. Final Selection of the candidates shall be decided and results declared, inter-alia, based on the guidelines issued by the Department of Personnel & Training vide O.M. No. 36012/2016/2019-Estt (Res.) dated 12.04.2022 subject to final

outcome of the Civil Appeal No. 629 of 2022 arising out of SLP (C) NO. 30621/2011.

- 6. The result is further subject to the final outcome of the SLP No. 30621/2011 and 31288/2017, which are pending before the Hon'ble Supreme Court of India in the matter of 'reservation in promotion' and 'own merit' and any other pending Court case(s) having a bearing on the result of the Examination before any Court of Law.

- 8. The mark sheets of candidates, who have not qualified, will be uploaded on the Commission's website within 15 days from the date of publication of the final result and will remain available on the website for a period of 30 days. No mark sheet for those candidates, whose candidature has been cancelled, will be issued.
