5. Final Selection of the candidates shall be decided and results declared, inter-alia, based on the guidelines issued by the Department of Personnel & Training vide O.M. No. 36012/2016/2019-Estt (Res.) dated 12.04.2022 subject to final

outcome of the Civil Appeal No. 629 of 2022 arising out of SLP (C) NO. 30621/2011.

6. The result is further subject to the final outcome of the SLP No. 30621/2011 and 31288/2017, which are pending before the Hon'ble Supreme Court of India in the matter of 'reservation in promotion' and 'own merit' and any other pending Court case(s) having a bearing on the result of the Examination before any Court of Law.
